In accordance the Pinal County Air Quality Control District Code of Regulations (PCAQCD Code), Chapter 4, Emissions from Existing and new Non-point sources, Article 3, Construction Sites " Fugitive Dust and Article 7, Construction Sites in Nonattainment Areas " Fugitive Dust, this acknowledges receipt of your earthmoving activity registration form or dust permit application/dust plan form and fee and authorizes earthmoving activities at the location and parcel number noted above.

**ATTAINMENT AREA CONSTRUCTION DUST RULE
EARTHMOVING ACTIVITY REGISTRATION ACKNOWLEDGMENT**

Earthmoving activities are allowed under the terms and conditions provided in the registration form regarding measures to be used to control dust during the earthmoving activity and PCAQCD Code "§4-3-090. All registrants shall keep records documenting actual application or implementation regarding the control measures chosen for at least 30 days following the expiration date of this document. A demonstration of compliance typically includes a daily written log at the work site, or the maintenance of invoices and/or payments reflecting the cost of the control measures.

The requirements of the Universal Performance Standard ("§4-3-090) must be complied with:

1. " Within the affected area, a landowner or contractor shall not conduct or allow dust generating operations:
 - a. " In a manner such that an unreasonable amount of dust is blown into sensitive areas so as to create a public nuisance;
 - b. " In a manner such that opacity of the dust leaving the property exceeds twenty percent (20%) or greater as measured using Test Method 9 (40 CFR 60, Appendix A) or an equivalent test method approved by the Control Officer and EPA Administrator;
 - c. " In a manner that will produce visibility impairment that could threaten public safety.
2. " Failure to comply with these requirements shall presumptively constitute cause for the Control Officer or his authorized representative to order a halt to the offending activity. Failure by an owner, contractor or facility operator to respond to such an order from the Control Officer shall constitute a violation of this rule.
3. " For control measures and work practices see Registration Form.

Notify the Control Officer within five working days of the start and completion of the project.

DUST PERMIT ACKNOWLEDGMENTS**

The Permittee acknowledges obligations to, and liability for failure to:

1. " Assure that any earthmoving activity on the site is covered by the Permit;
2. " With respect to the site:
 - a. " Comply with or cause compliance with the objective standards of "§4-7-226.
 - b. " Comply with or cause compliance with the obligatory work practice standards of "§4-7-230.
 - c. " Comply with or cause compliance with commitments in the dust management plan submitted in support of the Permit application

In addition your signature also affirms that you have the authority to commit the named permit applicant to comply with the aforementioned requirements.
